

CPDS for 2022 - IMPORTANT ANNOUNCEMENT



For 2022 the Interiors Association is delighted to introduce a Continuing Professional Development (CPD) programme for Full and Associate members. We recommend that student & graduate members participate also. CPDs are the way by which all professionals maintain and update their industry knowledge and skills after formal education. They are a method of increasing knowledge, understanding and experience. The Interiors Association advocates the Continued Professional development of its members and have introduced a number of training events to help our members complete their annual CPD requirement. This requirement can consist of both of structured and unstructured activities as detailed below. The CPD points requirement for 2022 is 14 (of which a maximum of 7 can be unstructured).

STRUCTURED CPD points must be accrued from a minimum of 3 activities from the following list:

- Attending live CPD approved training, courses, seminars, programmes and conferences. Check below for relevant CPD points attached to current courses.
- Online and in-person CPD approved workshops. Check below for relevant CPD points attached to current courses.
- Accredited CPDs from suppliers to the trade
- · Authorship writing an article, manual or book that is published for a professional audience
- Third level accredited qualification / programme eg an academic course that has a clear relationship to the practice of interior design (such as an MA in Interior Design)
- · Attending an IA training event
- CPD offered by other built environment organisations (eg RIAI)
- · Attendance at the AGM
- Formal teaching developing and delivering learning for others that includes clear accredited learning objectives or setting / marking examinations
- Formal Mentoring / Peer Review
- Service on the IA committee, volunteering or assisting with IA activities

UNSTRUCTURED* CPD points may be accrued from a the following list:

- Listening to interiors related podcasts
- Giving a talk or participating in a panel discussion at an exhibition or trade show

- Reading interiors related journals, magazines, and books (online and hardcopy)
